CONSENT-TO-PUBLISH AGREEMENT – CONTRIBUTOR TO EDITED BOOK

To: **Suzanne LaLonde** (hereafter the Author)

The Kent State University Press (hereafter the Press) is pleased to have the privilege of publishing your contribution (hereafter the Work) entitled: “**The Feeling of What Happens During a Plague:**

Dr. Rieux’s Metaphysical and Narrative Chronicle”

in the book entitled: **Albert Camus’s *The Plague*** (hereafter the Book)

edited by: **Woods Nash** (hereafter the Editor)

So that you as Author and the Press as publisher of the Work may be protected from the consequences of unauthorized use of its contents, the Press considers it essential to register the copyright. To this end, we ask you to grant us all rights in your Work. Following are the terms of publication:

1. The Press agrees to publish the Work in the Book, copyright by the Press, upon acceptance of the Work for publication by the Editor of the Book and, further, upon its formal and final approval for publication by the Press’s editorial board.
2. The Author hereby grants and assigns exclusively to the Press each and every right (including the copyright) in the Work under all laws, treaties, and conventions throughout the world, in all forms, languages, and media, now or hereafter known or developed, including without limitation all of the exclusive rights given authors under the United States Copyright Law.
3. The Author expressly warrants the Author’s sole ownership of the Work and full power to grant copyright and any of the exclusive rights under United States Copyright Law, and that it is not a violation of any other copyright nor of any proprietary right. The Author further warrants that none of the material included in the Work has been previously published or, if it has been previously published in whole or part, that the Author has obtained an assignment of copyright in the name of the Press. Such assignment shall be submitted with the Author’s manuscript.
4. The Author understands and agrees that the Press may edit the Author’s manuscript of the Work to conform to a style of presentation, spelling, capitalization, and usage that it deems appropriate, and the Author or Editor shall have the opportunity to read and correct the edited manuscript, and agrees to return on schedule the corrected manuscript to the Press or the Editor as arranged.
5. The Author warrants that the Work is not libelous, and the Author agrees to hold harmless and defend the Publisher against any claim by reason of any violation of another copyright or any proprietary right or by reason of any libelous matter in the Work.
6. Upon the Author’s written request, the Press will grant gratis to the Author a nonexclusive license to republish the Work in any language in a book written or edited by the Author after the Book has been published. The Press will inform the Author of the required wording of the copyright notice.
7. The Author will receive no royalty or other monetary compensation for his/her Work, but in lieu thereof the Work will be printed by the Press, and the Author will receive one (1) free copy of the published Book. The Author may purchase additional copies of the Book for his/her own use but not for resale at a forty percent (40%) discount from the Press’s list price.
8. Fifty percent of all monies in excess of \$25.00 collected as permissions fees for the use of the Work by others, as granted by the Press, will be paid to the Author. No such payments can be made without the Author’s personal information (below) including Social Security Number, citizenship, and date of birth.
9. Special Provisions:
